



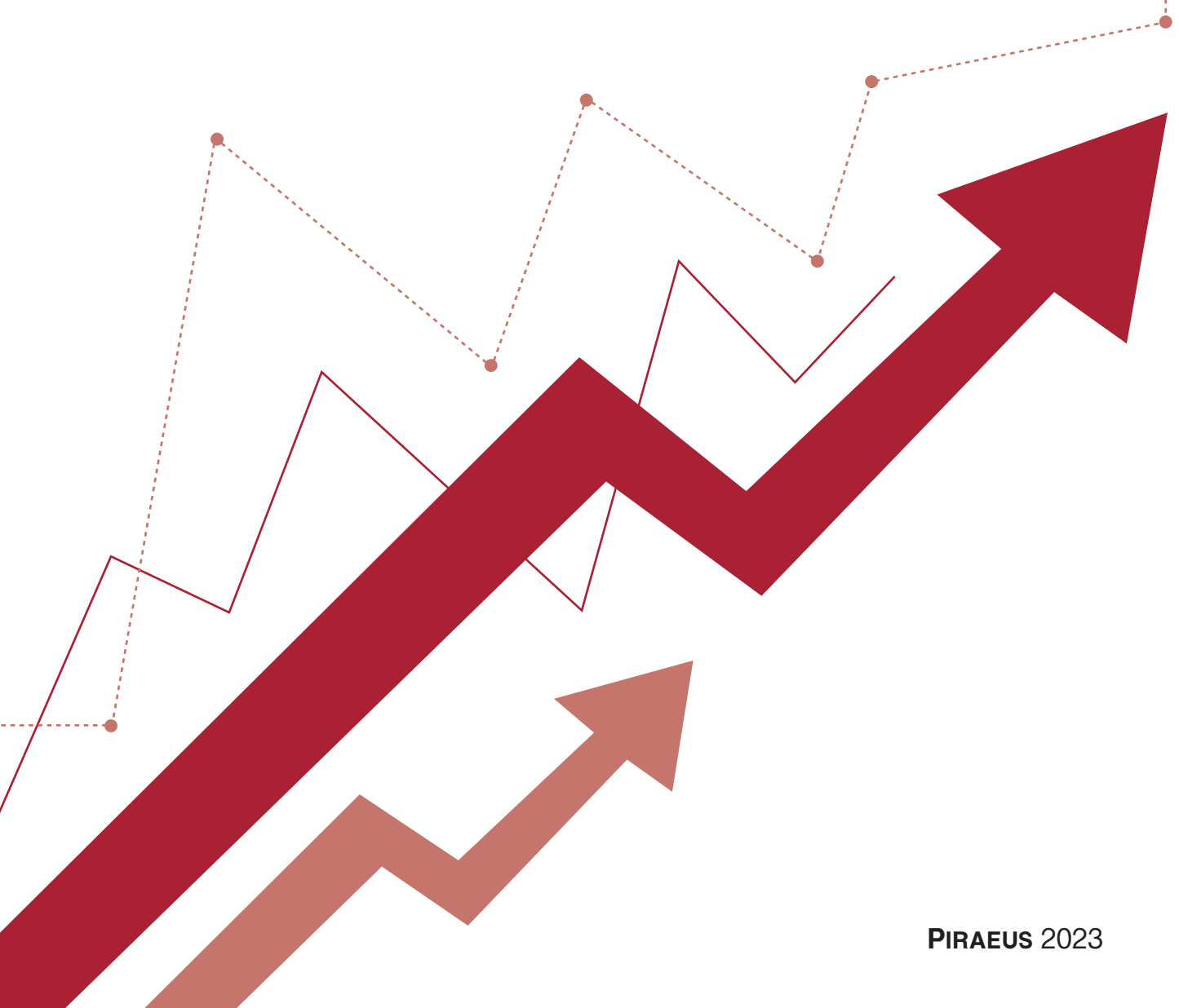

A. INTRODUCTION

The Annual Statistical Work Programme of the Hellenic Statistical Authority (ELSTAT) for the year 2023 (hereinafter 2023 AWP) includes information on the statistics to be compiled and disseminated during 2023 (see Annex), as well as on the planned changes to already produced statistics. These changes concern either the production of new statistics, due to the implementation of new European Regulations, or the amendment of produced statistics, in order to fully comply with existing European Regulations and/or to respond more effectively to the needs of national and international users. In addition, the 2023 AWP includes information on the planned actions of ELSTAT, for 2023, that aim at further enhancing the quality of its statistics and the access of users to them. The 2023 AWP has been compiled on the basis of the Hellenic Statistical Programme (ELSP) for the three-year period 2023 – 2025.

ELSTAT has set as a primary objective for 2023 –as in all its previous annual statistical programmes– the further improvement of completeness, quality and timeliness of its statistics, by unswervingly observing the national and European statistical legal framework⁽¹⁾ in force and by adopting the highest standards and best practices of the European and International Statistical System. In this context and in line with the prevailing trend in the European Statistical System (ESS), ELSTAT aims to further exploit administrative and other data sources, as well as to make use of new technologies for the production of its statistics, with the aim of saving human and financial resources and reducing the burden on the surveyed units.

Among ELSTAT's objectives, for 2023, remains the coordination of and cooperation with the agencies of the Hellenic Statistical System (ELSS), as well as the maintenance of its active role in the ESS. The election, in July 2022, of the President of ELSTAT, Mr. Athanasios C. Thanopoulos, as President of the Partnership Group (PG), the high-level group of elected Heads of National Statistical Institutes (NSIs) of the ESS, marks the unreserved and wide recognition by his counterparts, and of the ESS in general, of the significant and steady progress made in recent years in the field of official statistics of our Country, and the consolidation of the reliability of statistics of Greece. Mr. Thanopoulos is the first Greek who is elected and undertakes the post of the President of the Partnership Group, since the creation of the institution, at a crucial time during which the PG will be asked to identify the main guidelines for the revision of the European Statistical Regulation 223/2009, which constitutes the basic legislative act for the planning, development and dissemination of European official statistics. The revision of this Regulation will shape the future developments in the field of European statistics.

Finally, ELSTAT, recognising the importance of fostering statistical literacy in Greece, aims, from 2016, to the further development of the actions of its strategy, regarding cultivation and strengthening of statistical awareness among the general public.

B. NEW AND EXPERIMENTAL STATISTICS

1. Implementing European Regulations, and fulfilling European and international obligations and national needs

The statistical obligations of our Country towards the European Commission (Statistical Office of the European Union – Eurostat) and other European and international organisations mainly consist of the trigger for the production of new statistics by ELSTAT, in 2023. These obligations involve implementing new European Regulations, ensuring compliance with existing Regulations, utilising already existing surveys for the production of new statistics, updating of databases, etc.

In addition, ELSTAT, in the framework of its mission to produce up-to-date and useful statistics for citizens, businesses and policymakers, continues to produce experimental statistics launched in 2020, whose main objective is to provide direct statistical information on selected important issues of the economic and social life of Greece, reflecting, inter alia, the short-term circumstance.

The new statistics, as well as the experimental statistics scheduled to be produced in 2023 for the above purposes, are the following, by theme:

(1) Law 3832/2010, as in force, European Statistics Code of Practice, after its revision adopted on 16 November 2017 by the European Statistical System Committee, and Regulation (EC) 223/2009, as amended by Regulation (EU) 2015/759.

1.1. NEW STATISTICS

- BUSINESS STRUCTURE
 - *Extending the coverage of Structural Business Statistics in the sectors P (Education), Q (Human health and social work activities), R (Arts, entertainment and recreation) and for the branch S96 (Other personal service activities) of the statistical classification of economic activities NACE Rev. 2 (Regulation (EU) 2019/2152).*
- INTERNATIONAL TRADE OF GOODS
 - *Statistics on the number of enterprises with more than 50 employees, of the branches of economic activity B to N of the NACE Rev. 2, by business operation and geographic region, in the framework of the Global Value Chains and International Sourcing Survey, with reference period 2018 – 2020 (Regulation (EU) 2019/2152). The dissemination of the said statistics is scheduled to take place in 2023.*
- INFORMATION SOCIETY
 - *Statistics on: a) the use of electronic identification (e-ID), b) e-skills and c) the protection of privacy and personal data, in the framework of the Survey on the Use of Information and Communication Technologies (ICT) in Households by Individuals, of 2023 (Regulation (EU) 2022/1399, Implementing Regulation (EU) 2019/1700).*

1.2. EXPERIMENTAL STATISTICS

- DEMOGRAPHY
 - *Weekly data on deaths, based on primary data from the Registries.*
- BUSINESS REGISTERS
 - *Statistics on the evolution of turnover of enterprises.* This publication is the continuation of the Press Releases published by ELSTAT on the Evolution of Turnover of Enterprises under Suspension of Operation, due to the COVID-19 pandemic.
 - *Statistics on the evolution of turnover of enterprises in accommodation and food service activities.* The aim of these publications is to map the evolution of the turnover of enterprises classified in the Accommodation, and Food and Beverage Service Activities divisions. These economic activities have been over time in the focus of interest, due to the significant weight they bear on the Greek economy as a whole, but also due to their extensive dispersion, with a significant presence in all Regional Units and a significant contribution to the respective local economies of Greece, often associated with the tourist product of the Country.
 - *Statistics on the evolution of turnover of enterprises in retail trade.* The aim of these publications is the detailed presentation of the evolution of the sales/turnover of all classes of activity of the retail trade sector, which has always been an important productive tertiary sector of the Greek economy, with a significant contribution to the Gross Domestic Product. The monitoring of the evolution of the aggregates of the retail trade activity classes is important due to the resulting conclusions on the evolution of consumption (in terms of volume, characteristics, preferences and substitution of products) of the Greek society, the citizens and the enterprises of the Country.
- INTERNATIONAL TRADE OF GOODS
 - *Statistics on the expected value of exports of goods in 2023 compared to 2022, in percentage terms of change, with the aim of capturing the expectations of enterprises regarding the exports that they are going to carry out during 2023, providing an ex-ante estimate of the trend of change in Greek exports of goods, between 2022 and 2023.*
- LIVING CONDITIONS OF LGBTIQ PERSONS
 - *Pilot survey on the living conditions of LGBTIQ people and on the discrimination due to sexual orientation.*

2. 2021 General Censuses for Buildings and for Population – Housing

After the completion of the conduct of the 2021 Population – Housing Census, the post-census work has started and continues. This work mainly concerns the data processing for the production of the results on the Resident Population of the Country, as well as for the extraction of the results on the Registered (De Jure) Population of the Country, which will be announced, in accordance with the constitutional obligation, 1 year after the end of the conduct of the Census. At the end of 2022 aggregated data and metadata on the total population, geocoded to a 1 km² grid will be submitted to Eurostat, by virtue of Regulation (EU) 2018/1799 of the Commission.

The processing of the census material will continue in 2023, with the conduct of quality and completeness checks of the variables, taking into account relevant data from administrative sources, with the aim of on the one hand evaluating the Census results and on the other hand preparing the compilation of Statistical Registers on Buildings and Population, provided for in Law 4772/2021 (Government Gazette No 17 / Issue A').

3. Satisfying users' needs

ELSTAT, taking into consideration the comments and suggestions of the users of its statistics (including those who make public policies), records their needs and includes them in its priorities. The main communication channels of ELSTAT with the users are the User Conferences it organises and the User Satisfaction Survey it conducts.

In this context, in 2023, ELSTAT is planning the following actions:

- Compilation of additional Public Use Files (PUFs)⁽²⁾, as well as of standardised Scientific Use Files (SUFs)⁽³⁾ of ELSTAT's statistical surveys, according to predefined anonymisation criteria of the microdata of the surveys.
- Continuation of its work on the establishment of a safe centre, where authorised researchers will be able to access confidential data for scientific purposes, on which no methods of statistical disclosure control have been applied.
- Continuation of the coordination of the ELSS agencies for the development and monitoring of the 2030 individual Indicators of the Sustainable Development Goals (SDGs) of the United Nations and with constant cooperation with the international agencies (custodian agencies) that have under their responsibility the compilation of individual Sustainable Development Indicators.
- Further exploitation of data from administrative and other sources, as well as of the use of new technologies, with the aim of improving the quality, reducing the production time of statistical outputs in various areas, saving resources and reducing the burden on respondents
- Conduct of a pilot survey for the compilation of statistics disaggregated in population groups with sensitive characteristics.

ELSTAT, in order to collect feedback for its statistical product and services from more users of its statistics, will proceed to the redesign of the User Satisfaction Survey, which is currently addressed only to users who request the provision of statistical data. The redesign of the survey will consist of:

- Simplification of the already used online questionnaire for the users who request the provision of statistical data, so that it is more friendly for them.
- Development of a new online questionnaire that will be posted in a prominent place on the main webpage of ELSTAT's website and will be addressed to all users who have access to its statistical data.

(2) It concerns anonymised microdata files of ELSTAT's statistical surveys, which have been anonymised on the basis of predefined anonymisation criteria by ELSTAT, so as to render impossible the direct or indirect identification of the surveyed units.

(3) It concerns anonymised microdata files of ELSTAT's statistical surveys, which allow the indirect identification of the surveyed units.

C. OTHER CHANGES IN THE COMPILATION AND DISSEMINATION OF STATISTICS

Compliance with European Regulations and adaptation to users' needs, in combination with constraints in terms of the available human and financial resources, necessitate changes: improvements, revisions or discontinuations in the production and dissemination of statistics.

In the context of modernising European statistics and aiming at increasing their coherence and comparability, while reducing the burden on the surveyed units, the Commission (Eurostat) is preparing the following legislative Proposals, to be submitted to the European Parliament and to the Council:

- Proposal for a Regulation on European Fisheries and Aquaculture Statistics.
- Proposal for a Regulation amending Regulation 691/2011 on European environmental economic accounts (the Proposal will be discussed for the first time at the meeting of the Council Working Party on Statistics (CWPS) of September 2022, under the Czech Presidency).
- Proposal for a Regulation on European Statistics on Population (ESOP).
- Proposal for a Regulation amending Regulation 223/2009 on European statistics, which will be discussed for the first time at the meeting of CWPS of September 2022, under the Czech Presidency.

In addition, the following changes are planned for 2023:

- DEMOGRAPHY
 - *Modification of the statistics regarding the Cohabitation Agreements, by number of previous Agreements, by analogy with the statistics on marriages*, in the framework of the Natural Movement of Population Survey. The dissemination of these statistics is scheduled to take place in 2023.
 - *Change in the compilation of statistics on Divorces, by using data from the Country's Registries*, with the aim of continuing the production of the relevant statistics by the Population and Immigration Statistics Section.
- LABOUR MARKET
 - *Reduction of the weeks for transmitting to Eurostat of the quarterly data of the Labour Force Survey, from 10 to 8 after the end of the reference period (quarter)*, from 2023 instead from 2024 (Regulation (EU) 2019/1700), with a corresponding presentation of the data at national level.
 - *Improvement of the seasonal adjustment model* using JDemetra+ instead of Demetra 2.0, from the 1st quarter of 2023, and change of the base year, from 2016=100.0 to 2020=100.0, of the Labour Cost Indices in enterprises.
 - *Investigation of the use of a web questionnaire (CAWI) to collect data on adult education*, in the framework of the Labour Force Survey.
 - *Improvement of the seasonal adjustment model of the results of the Job Vacancy Survey and collection of the survey data by electronic means (use of an electronic questionnaire)*, with the aim of improving the quality of the results and reducing the administrative burden.
- JUSTICE
 - *Study for the creation of an automated process for collecting the data of the Survey on Land Registries*, in collaboration with the Hellenic Cadastre.
 - *Investigation of new administrative sources for collecting the data of the Survey on Convicted Persons*, in collaboration with the Ministry of Justice.
- EDUCATION AND TRAINING
 - *Development of cooperation with the Ministry of Education and Religious Affairs*, for the provision of data for the needs of the Survey on Private Schools of Primary and Secondary Education, through the myschool platform.

- BUSINESS REGISTERS
 - *Change in the mode of data processing for the compilation of the Statistical Business Register*, through the development of a database, with the aim of: a) automating the relevant compilation procedures, b) improving the quality and comparability of its data over time, by incorporating automated checks and c) increasing the speed of processing users' requests for the provision of Register data.
 - *Change in the mode of data processing for the compilation of the European Groups Register (EGR)*, through the development of a database, with the aim of: a) automating the relevant compilation procedures, b) improving the quality and comparability of data over time, by incorporating automated checks and c) producing in an automated way tables with Register data, which are transmitted to Eurostat.
 - *Development of a special application for processing and producing the final results of the Survey on Intragroup Transactions*, with the aim of automating the relevant procedures and improving the quality of data, by incorporating automated checks.
- BUSINESS STRUCTURE
 - *Change in the mode of data collection for the Structural Business Survey*, by using a web application, with the aim of: a) facilitating the enterprises in filling-in the questionnaire and b) reducing the time of collecting and processing the data, and producing the results.
- SHORT TERM INDICES
 - *Change of the base year, from 2015=100.0 to 2021=100.0*, of the: a) Turnover Index in Retail Trade, b) Turnover Index in Wholesale Trade, c) Turnover Indices in the Services Sector, d) Producer Price Indices in Services and e) Turnover Index in Motor Trade.
- INDUSTRIAL PRODUCTION
 - *Implementation of the PRODCOM product list, of 2022*, in the framework of conducting the Survey on the Production and Sales of Manufacturing Products (PRODCOM).
- INTERNATIONAL TRADE
 - *Greater analysis of currencies*, in the framework of the Survey on International Trade in Goods Statistics, by Invoicing Currency (Regulation (EU) 2019/2152 on European Business Statistics (EBS) and Implementing Regulation (EU) 2020/1197).
 - *Linking of international trade in goods statistics, by business characteristics, with variables of business statistics and of foreign affiliates trade statistics, and change of the due date for compiling the above statistics, from T+18 months to T+12 months from the end of the reference year T*, in the framework of the Survey on International Trade in Goods Statistics, by Business Characteristics (Regulation (EU) 2019/2152 on European Business Statistics (EBS) and Implementing Regulation (EU) 2020/1197).
- AGRICULTURAL PRICES AND INDICES
 - *Change of the base year of the Agricultural Price Indices (APIs), from 2015=100.0 to 2020=100.0*. The work for the change of the base year of the APIs started in 2022, but will be completed in 2023. According to the current ESS agreement, the new weighting factors should be transmitted in June 2023 and the new time series in December 2023.
- INFORMATION SOCIETY
 - *Cessation of production of statistics of the Survey on the Use of Information and Communication Technologies (ICT) in Households by Individuals*, concerning the following:
 - a) e-government services,
 - b) Internet of Things,

c) Green ICT,

d) internet activities, such as: entertainment (music, watching internet television, video on demand, video from You Tube), e-Health, online appointment, via website or via application, with a practitioner (of a hospital, of a health care centre, private practitioner), online access to personal medical records and use of health services (prescription, consultation, etc.), via website or application, in accordance with Regulation to be adopted Implementing Regulation (EU) 2019/1700.

D. IMPROVING THE QUALITY OF PRODUCED STATISTICS

In 2023, ELSTAT will continue its actions to ensure and further improve the quality of its produced statistics and to uphold users' confidence in them. These objectives will be accomplished by fully implementing the national and EU legal and institutional framework on statistics and by adopting the highest standards and best practices of the European and International Statistical System.

Among the specific actions to be undertaken by ELSTAT in 2023, aimed at accomplishing the above objectives, are the continuation of its close cooperation with the ELSS agencies and the support of their statistical activities, in the framework of the certification process of their statistics.

Besides the above actions, a series of actions is envisaged in areas such as: using technology to upgrade data collection, further utilising administrative and other data sources for the production of statistics, reducing the burden on respondents, training the staff of ELSTAT and of the other ELSS agencies, as well as fostering statistical literacy.

1. Conduct of the 3rd round of Peer Reviews

In the framework of the 3rd round of Peer Reviews conducted in all Member States of the European Union and of the European Free Trade Association (EFTA), as well as in Eurostat, with the aim of assessing the compliance with all the Code of Practice (CoP) Principles, ELSTAT, in 2022, participated in that process.

The Peer Review of the 3rd round was carried out in our Country on 17 – 21 October 2022. The team of reviewers appointed for this purpose assessed the compliance of ELSTAT and of the 3 other National Authorities of the ELSS that participated in the Peer Review (Ministry of Labour and Social Affairs, Ministry of Environment and Energy, National Documentation Centre) with the 16 CoP Principles. On the basis of the findings of the above assessment, the reviewers will compile a Report, in which any recommendations for ELSTAT and the other 3 National Authorities that participated in the Peer Review will be included, with the aim of fuller complying with the CoP Principles.

In this context, ELSTAT will take the necessary actions to determine, plan and conduct the improvement actions that should undertake to implement the recommendations of reviewers. In parallel, in case the Report of reviewers also includes recommendations for the other 3 ELSS agencies that participated in the Peer Review, ELSTAT, in the framework of its coordination role in the ELSS, will provide guidance for the determination of the relevant actions.

The Report is expected to be published in March 2023, while the reviewers, already during their visit, found that ELSTAT, for the first time, is one of the few NSIs of the ESS that is in line with all the CoP Principles.

2. Coordination of ELSS agencies – Certification as "official" of the statistics of ELSS agencies

ELSTAT, in the framework of its coordinating role in the ELSS, will continue, during 2023, its close cooperation with the ELSS agencies, for the continuation and completion of the certification process of their statistics. For this purpose, it will undertake, within 2023, further initiatives, if necessary, in order to speed up the certification process of the agencies' statistics.

3. Implementation of the General Data Protection Regulation

ELSTAT, in the framework of implementing Regulation (EU) 2016/679 of the European Parliament and of the Council, on the protection of natural persons with regard to the processing of personal data and on the free movement of such data (General Data Protection Regulation – GDPR), has completed, during the previous years, a series of important actions, which resulted in its full compliance with the GDPR provisions.

In 2023, the work of assessing the implementation of GDPR will continue, within ELSTAT, so that to increase the level of consolidation of the GDPR provisions by ELSTAT's staff and to ensure full and correct implementation of these provisions in the daily work of the staff. In particular, as, in 2023, 5 years have passed since the start of implementation of GDPR, ELSTAT plans the conduct of specialised actions of personalised assessment of the consolidation and implementation of the GDPR provisions in the daily work of each ELSTAT's employee, but also at the level of organic units. The findings of the above actions will be included in an evaluation report and used as a guide for future improvement interventions.

Moreover, relevant training and information actions for newly hired employees in ELSTAT will be carried out, so as to achieve the same level of awareness as of the existing staff. In addition, the actions that aim at cultivating culture and informing – training the staff, which have started since 2018 and include educational seminars and informative one-day conferences on specialised issues of GDPR implementation for the production of official statistics, addressed to the entire ELSTAT's staff, will continue, with the coverage of new relevant topics. Specifically, within 2023, the conduct of targeted staff training and information programmes, which will now concern more specialised issues on GDPR implementation in the area of the production of official statistics, will continue.

Finally, depending on the results of the assessment, there will be corrective actions and readjustment of the implementation measures, if this is deemed necessary. As a continuing action, the policies related to the GDPR implementation in ELSTAT will be updated, as the case may be, where required, while at the same time new ones will be developed, where this is necessary, to cover new needs and areas of action. In parallel, the log files of the activities of ELSTAT's organic units concerning the processing of personal data, as well as the files of the detailed recording of the procedures followed by the above organic units will be evaluated and updated.

4. Using technology to upgrade data collection

In 2023, ELSTAT will continue its actions to exploit the possibilities offered by modern technologies for data collection and processing.

More specifically, in 2023, ELSTAT will take the following actions related to the use of new technologies:

- Development of an electronic application, for the collection of data of the Labour Cost Survey, the Job Vacancy Survey and the Adult Education Survey.
- Creation of an electronic web application, for the compilation of Global Value Chains (GVC) statistics, which is a new European statistical area, with work in progress.
- Improvement of the existing web application, on the basis of a single questionnaire, for the collection and processing of Structural Business Survey data, in accordance with the new European Regulation (EU) 2019/2152.

5. Utilising administrative data sources for the production of statistics

The European and international statistical community have focused on the utilisation of administrative data and data from other sources, such as Big Data and privately held data, for the production of statistics. In line with the prevailing trend, ELSTAT has proceeded to the signing of memoranda of cooperation with the ELSS agencies and has developed close cooperation with administrative data sources. ELSTAT will seek to continue and further develop its cooperation with administrative data sources, formalising such cooperation by signing memoranda of cooperation, where necessary.

In this context, ELSTAT plans to develop/continue, in 2023, a series of cooperation actions with administrative sources, with a view to maximising their utilisation, in order to meet the needs of specific statistical surveys/tasks. Indicatively, the following actions are stated:

- Continuation of the cooperation with the General Commercial Registry (GEMI), for the provision of business data that are held electronically in GEMI.
- Continuation of the cooperation with the Independent Authority for Public Revenue (IAPR), for the provision of data from the Tax Form "Report by Country on Multinational Enterprise Groups", in the framework of the production of new statistics on enterprise groups and the change in the methodology of compilation of the Statistical Business Register, as well as for the provision of data from other Income Tax Forms, for updating the Statistical Business Register and the compilation of structural business statistics.
- Expanding the cooperation with the IAPR, with the aim of utilising data on electronic distance sales from businesses to individuals in another Member State, in the framework of compiling statistics on intra-EU trade.
- Continuation of the cooperation with the IAPR, for the provision of data on the income of wage-earners.
- Continuation of the cooperation with the Customs Authorities, with the aim of utilising available data in them, in the framework of the compilation of trade statistics with third countries.
- Continuation of the cooperation with the IAPR and the Bank of Greece (BoG), with the aim of utilising available data for the needs of the International Trade in Services Survey of the BoG.
- Continuation of the cooperation with the IAPR, for the provision of data regarding the short-term rental and the accommodation tax, in the framework of improving tourism statistics.
- Continuation of the cooperation with the Unified Agency of Social Insurance (EFKA) and the Single Payment Authority (EAP), for the provision of data of the above entities for updating the Statistical Business Register.
- Continuation of the cooperation with the EFKA, for the provision of data on pensions.
- Continuation of the cooperation with the Organisation of Welfare Benefits and Social Solidarity (OPEKA), for the provision of data on social benefits.
- Development of cooperation with the Ministry of Interior, in the framework of the breakdown of the Co-habitation Agreements by number of previous Agreements.
- Continuation of the cooperation with the Ministry of Rural Development and Food and the Payment and Control Agency for Guidance and Guarantee of Community Aid (OPEKEPE), for updating the Statistical Agricultural Register of ELSTAT, on a yearly basis.
- Continuation of the cooperation with the Ministry of Digital Governance (General Secretariat of Information Systems for Public Administration), the IAPR and the Ministry of Immigration and Asylum, for the utilisation of their available data, in the framework of the conducted quality checks of census data.
- Continuation of the cooperation with the Ministry of Tourism, in the framework of the compilation of Tourism Satellite Accounts.
- Continuation of the cooperation with the National Centre for Social Research (EKKE), in the framework of the conduct by EKKE of the Gender-based Violence Survey and the production of the relevant statistics.
- Continuation of the cooperation with the Hellenic Authority for Higher Education (HAHE), with the aim of harmonising the national data, in the field of higher education.

- Development of cooperation with the Hellenic Cadastre, with the aim of utilising administrative data for the needs of the Survey of Land Registries.
- Development of cooperation with the Ministry of Education and Religious Affairs, for the provision of data from the myschool platform, for the needs of the Survey on Private Schools of Primary and Secondary Education.
- Development of cooperation with the Ministry of Shipping and Island Policy, for the utilisation of administrative data of its information systems, such as the Electronic Reservation System and the National Single Window NSW/SSNET, in the framework of producing the passenger and freight traffic statistics.

E. ENHANCING ACCESSIBILITY OF PRODUCED STATISTICS

1. Upgrading the portal of ELSTAT

ELSTAT has adopted a strategy for the dissemination and communication of its statistics, putting users at the heart of its activities. In this context, it seeks to continuously upgrade the statistical products and their dissemination and communication means, in line with evolving international standards and making the most of digital tools for the creation of innovative products, by enhancing the format and enriching the content of its portal.

Therefore, in 2023, ELSTAT will continue to: a) enrich its portal with time series of produced statistics and with public use files, b) develop standardised scientific use files, for the needs of researchers, with predefined anonymisation criteria of the microdata of its relevant statistical surveys, c) display selected statistics, as well as their production processes, with infographics, aiming at presenting them in a way comprehensible to the general public and suitable for reproduction also in the social media and d) to utilise the social media to promote its statistical work.

To speed up the access process for researchers to standardised scientific use files, while reducing the administrative burden, ELSTAT plans to post them on its website. The access of researchers to the files will be granted upon submission of their research proposal, fully and correctly completed, and the signing of the relevant contract for the observance of statistical confidentiality, of the declaration for personal data and of the authorisation forms, where required.

In addition, ELSTAT is considering enriching its portal with new search capabilities and extracting statistical results, based on criteria and personalised questions, which will be configured by the user through an easy-to-use and flexible search environment. In parallel, the system will also provide advanced visualisation capabilities of the results.

2. Fostering Statistical Literacy

In 2023, ELSTAT will continue its strategy concerning "Fostering Statistical Literacy" in Greece.

The objective of ELSTAT is to:

- inform about the applications of Statistics in everyday life,
- develop statistical consciousness,
- inform pupils/students about the production processes of official statistics,
- inform about the CoP Principles and in particular about Principle 5 regarding the observance of statistical confidentiality and data protection,
- consolidate statistical literacy in our Country, by creating a long-lasting and evolving relationship between trainees and ELSTAT.

For 2023, ELSTAT plans the following actions:

1. Taking initiatives aimed at expanding the awarding of the European Master in Official Statistics (EMOS) label and in other university institutions of the Country, apart from the Aristotle University of Thessaloniki and the Athens University of Economics and Business, to which the specific label has been awarded.
2. Continuation of ELSTAT participation in the Cross-Border Internship Programme, whose organisation has been assigned by Eurostat to the company DevStat. ELSTAT, and more specifically its mentor representative, has the obligation to work closely with the intern, depending on the thematic area assigned to her/him, and to provide support, encouragement and information to the intern, depending on her/his work and experience in relation to the host institution (organisation culture, informal codes and behaviours, etc.).
3. Continuation of ELSTAT participation in the "Statistics Coded" initiative, organised by Eurostat for the EMOS students. ELSTAT participated for the first time in the said initiative during the time period September – November 2021, with 8 lectures and subject: "Data Analytics and Official Statistics". These lectures provide a learning opportunity of modern programming techniques, using the R programming language, as well as tools, such as the Github and the Slack. The programme was chosen by 8 students, while 4 of them completed it successfully.
4. Making web presentations, addressed to pupils of primary and secondary education schools, with the aim of promoting ELSTAT's work and informing them on the available results of the 2021 Population – Housing Census.
5. Continuation of the promotion to teachers and pupils of the educational programme "Census@School", with the ultimate objective of integrating it into the educational programme of primary and secondary education. After the completion of the educational programme, the participating teachers receive a certificate of participation, which is sent to them, as well as to the educational institution in which they work.
6. Promotion of the educational game developed on a web platform for PC, tablet and mobile phone, with the aim of infiltrating Statistics in the schools of secondary education, using new technologies.
7. Continuation of providing opportunities for practical training to students, at ELSTAT's premises.
8. Conduct of the 6th Hellenic Statistics Competition, separately for lower secondary schools and upper secondary schools, with the participation of teams of secondary school pupils from all over Greece.
9. Continuation of the cooperation with university schools, with the aim of preparing theses of postgraduate students, with thematology that will arise from a list of topics related to the development, production and dissemination of official statistics.
10. Sending printed statistical educational material to school libraries, as well as infographics, in order to be posted in school classrooms.
11. Distribution of educational and informative statistical material, during the International Exhibition of Thessaloniki.

In addition, ELSTAT is planning the following actions, in accordance with the prevailing conditions, due to the COVID-19 pandemic:

1. Resumption of educational presentations at ELSTAT's premises for pupils and students, in Athens and Thessaloniki.
2. Expansion of informative visits of ELSTAT executives to educational units, for which the access to ELSTAT's premises is difficult, due to distance or other reasons.
3. Continuation of the informative visits/speeches of the President of ELSTAT in educational institutions.
4. Continuation of ELSTAT's participation in the "Summer Vocational Guidance" programme, addressed to upper secondary education school pupils, with the aim that the experience gained by the pupils to be a

useful resource for their academic and professional career (the action is activated after a relevant request submitted by school units).

F. ORGANISATION OF CONFERENCES, INTERNATIONAL RELATIONS AND DEVELOPMENT OF STATISTICAL COLLABORATIONS

In the framework of renewing and improving the statistical products, of upgrading its services provided, as well as of cultivating cooperation bonds and strengthening the bilateral relations with the NSIs of EU Member States, but also of developing further collaborations in areas of common interest, ELSTAT, during 2023, plans the following actions:

1. Organisation of the 12th User Conference.
2. Visit of a delegation of the Statistical Office of the Republic of Cyprus to ELSTAT's premises. The conduct of this visit follows the visit of the delegation of ELSTAT to the Statistical Office of the Republic of Cyprus, in September 2019, and constitutes the continuation and strengthening of the cooperation of the 2 NSIs, in the framework of joint actions within the European and international community, with the aim of continuously ensuring quality and reliability of official statistics, as well as of closely cooperating with the producers and users of statistical data and responding to their ever-increasing needs.
3. Continuation of the organisation of visits of ELSTAT representatives to NSIs of other EU Member States. The aim of the visits will be the development of synergies, the exchange of know-how and experiences, in the framework of the ESS. A high-level tripartite meeting between the Statistical Office of Malta, the Statistical Office of the Republic of Croatia and ELSTAT is scheduled for November 2022, in Malta. The corresponding organisation is expected to be undertaken by ELSTAT, in Greece, in 2023.
4. Provision of expertise and statistical support by ELSTAT for the organisation of 4 educational programmes (similar to those of ESTP courses) for the ENP South countries (Algeria, Egypt, Israel, Jordan, Lebanon, Morocco, Palestine, Syria, Tunisia), of 2 years duration, as part of Eurostat's training programme "Lot 3: Training programme in the ENP South countries" regarding the quality and harmonisation of statistics, modernisation and innovations, capacity building and infrastructure, as well as the dissemination and communication of statistics with users. This particular programme was not held in 2022, due to the restrictions for the COVID-19 pandemic. It is expected to be activated within 2023.
5. Continuation of ELSTAT participation in IPA 2019 programme of Eurostat, intended to the provision, by the NSIs of the EU Member States, of training to statistical employees of the IPA countries (Albania, Bosnia and Herzegovina, Kosovo (UNSCR 1244/1999), Montenegro, North Macedonia, Serbia and Turkey).
6. Following the election of the President of ELSTAT, Mr. Athanasios C. Thanopoulos, as President of the Partnership Group (PG) of the ESS, with a two-year term, the 86th, 87th and 88th meeting of the said Group will be organised, in 2023, at ELSTAT. The PG is a high-level group, in which a restricted number of elected Heads of NSIs of the ESS participate. The mission of the PG is to develop the ESS, to ensure the effective functioning of the European Statistical System Committee (ESSC) and to highlight the strategic issues that need to be discussed in the ESSC. At the same time, it functions as the Crisis Response Team of the ESS. The PG meets 3 times a year.

G. ESTIMATED EXPENDITURE FOR THE IMPLEMENTATION OF THE STATISTICAL WORK PROGRAMME

The implementation of the 2023 AWP presupposes the allocation of the necessary resources from the State Budget and Eurostat, as well as the reinforcement of ELSTAT with the required and appropriate human resources. The Commitment on Confidence in Statistics contains explicit commitments for the Government and the Greek State to reinforce ELSTAT with the necessary resources, in order for ELSTAT to fulfill all its obligations, at national and European level, and to provide users with high-quality statistics.

The budgeted expenses, for 2023, are estimated at a total of 39,919,131.00 euro and are classified into the following categories:

- a) Labour cost (salaries of ELSTAT's staff, including basic salary, allowances (family allowance, liability position allowance, etc.), social security contributions, remuneration for overtime work, etc.).
- b) Expenses related to staff travel within Greece and abroad, i.e., travel, accommodation and daily allowance expenses for the employees of ELSTAT traveling:
 - in Greece, out of home or outside the office, for conducting statistical surveys in the field, and
 - abroad, for participating in meetings, seminars, etc., organised by Eurostat and other international organisations.

This category also includes expenses related to the redeployment or detachment of ELSTAT's employees to other agencies, in Greece or abroad.

- c) Other operating expenses, including expenses related to ELSTAT's buildings (Central and Regional Offices), such as rents, expenses for electricity, telecommunications, water supply, building security and maintenance, expenses related to advertising and public relations, subscriptions, expenses for the provision of consumables (paper, stationery, medical and pharmaceutical supplies, materials for the maintenance and repair of premises and equipment), fuel, etc. This category also includes expenses for the provision of capital formation goods (furniture, PCs, printers, photocopiers and other office equipment), as well as the remuneration of private collaborators, which are used by ELSTAT for the collection of data of statistical surveys it conducts.
- d) Expenses for projects financed by Eurostat (for the conduct of surveys, studies and other statistical tasks).
- e) Expenses for the Censuses of Agriculture – Livestock, Buildings and Population – Housing.

The following table presents the budget estimate of ELSTAT (in euro) for 2023, in comparison with the approved budget for 2022:
