Annual Statistical Work Program
2012

A. INTRODUCTION

The 2012 statistical work program of the Hellenic Statistical Authority (ELSTAT) includes information on the statistics to be compiled and disseminated during 2012 (see Annex), as well as on the planned changes in the compiled statistics. These changes pertain to the production of new statistics on account of, for example, the implementation of new European Regulations, to the amendment of currently produced statistics in order to fully comply with existing EU Regulations, and to the need to respond more effectively to the needs of national and international users. In addition, the 2012 statistical work program includes information on the planned actions of ELSTAT that aim at enhancing the quality of its statistical data as well as the access of users to statistics. Furthermore, the statistical work program includes the actions of ELSTAT for coordinating the activities of the other agencies of the Hellenic Statistical System (ELSS) concerning the development, production and dissemination of the official statistics of Greece, especially in light of the certification of the aforementioned statistics slated to be initiated in 2012.

The 2012 statistical work program of ELSTAT has been compiled on the basis of the Hellenic Statistical Program (ELSP) for the period 2011-2013. This multiannual statistical work program lays down the principal goals of the envisaged statistical activities and the priorities of the ELSS agencies—ELSTAT being one of them—for fulfilling their national and international statistical obligations for this three-year period.

B. NEW STATISTICS

1. Implementing EU Regulations and fulfilling European and international obligations

ELSTAT's production of new statistics slated for 2012 is driven, to a large extent, by the need to fulfill its obligations towards the Statistical Office of the European Union (Eurostat) and other European and international organizations. These obligations involve, *inter alia*, implementing new European Regulations, ensuring compliance with existing Regulations, filling in questionnaires, updating databases, etc. The new statistics, by theme, that are planned to be produced in 2012 for such purposes are the following:

- FISHERIES
 - *Statistics on aquaculture*, in the framework of adding new variables in the Aquaculture Survey (Regulation 762/2008).
- INCOME AND LIVING CONDITIONS
 - *Statistics on housing conditions of the households*, in the framework of a new ad hoc module in the EU-SILC survey for 2012 (Regulation 1157/2010).

- TRADE

- *Statistics on turnover distribution by product category (CPA) for wholesale and retail trade and for the repair of motor vehicles and motorcycles.* This concerns a new variable to be compiled in the framework of the Structural Business Survey in trade, sales and repair of motor vehicles and motorcycles, and retail sale of fuels, with reference year 2010 (Regulation 295/2008).

- INFORMATION SOCIETY

- *Statistics on the use of the Internet via mobile phone and technologies enabling connection to the Internet from anywhere,* in the framework of the new ad hoc module to be added in the Survey on the Use of Information and Communication Technologies by Households for the year 2012 (Regulation 937/2011 implementing Regulation 808/2004).

- PRICES

- *Cost indices for the factors of agricultural production.* Compilation of indices concerning purchase prices for agricultural land (voluntary agreement between Eurostat and the Member States).

- *Producer price indices in the services sector.* Compilation of the new indices (Regulations 1165/1998, 1158/2005, 1893/2006 and 451/2008).

- TOURISM

- *Statistics on rooms for rent in Greece.* The survey will be based on the relevant Register of the Greek Tourism Organization (EOT) (Regulation 692/2011).

- HEALTH

- *Statistics on net social protection benefits* with reference year 2010 (Regulation 263/2011 implementing Regulation 458/2007).

2. Satisfying users' needs

During the first Users Conference, which ELSTAT convened on 20 October 2010, users made comments and suggestions in a number of areas. In light of these comments and suggestions ELSTAT carried out a series of actions in 2011 and is planning to launch the following statistical activities in 2012:

A) Conduct of a Time Use Survey, in cooperation with the General Secretariat for Gender Equality, in the framework of the National Strategic Reference Framework for 2007-2013 and more specifically under the Sectoral Operational Program "Public Administration Reform". The preparatory works (funding proposal for the Program "Public Administration Reform", survey design, elaboration of questionnaires, sampling, development of software

applications for data checking and data entry, etc) started in September 2011 and will be completed in September 2012. Data collection will be carried out during the period October 2012 - September 2013. Data entry is planned for June 2013 and the survey results are expected in December 2014. The organization of an international conference is planned for end-2014 or early 2015.

B) Implementation of a System of Health Accounts (SHA) at national level, in the framework of the Memorandum of Understanding signed on 29 December 2010 between ELSTAT, the Ministry of Health and Social Solidarity, and the University of Athens. The timetable of actions, set out in the memorandum, for the development of the SHA spans the period from September 2011 to November 2012.

In 2011, ELSTAT staff were informed about the SHA by the University of Athens as well as by an external expert. The Joint OECD – Eurostat – WHO Data Questionnaire on SHA was translated into Greek. Furthermore, a report was produced outlining the need for aligning the national objectives for recording health expenditure with the SHA objectives, as well as the availability of primary data.

The actions to be taken within 2012 are the following:

- The University of Athens will provide ELSTAT with a manual on the transition from the national system for recording health expenditure to the System of Health Accounts.
- ELSTAT will provide all available statistical data on public health expenditure for the years 2003-2010, on the basis of the data collected through its surveys.
- ELSTAT, in cooperation with the University of Athens, will provide statistical data on total Health Expenditure (public and private health expenditure). Data on public expenditure will be based on estimations for the specific categories of expenditure for which no data are available (non-hospital health care). Data on private health expenditure will be compiled on the basis of Household Budget Survey results, after having the latter cross-checked with the revenue of health providers coming from households, as well as on the basis of the results of the surveys conducted by the University of Athens for several competent agencies (Ministry of Health and Social Solidarity, Ministry of National Defense, Local Government).

Box 1. The 2011 Users Conference

In the framework of its 2011 Annual Statistical Work Program, on 29 December 2011, ELSTAT convened the 2nd Users Conference on its premises in Piraeus. During the conference, ELSTAT presented the work accomplished since the 1st Users Conference (20.10.2010) and users had the opportunity to make their comments and express their needs with regard to statistical products and services provided by ELSTAT. Users pointed out, *inter alia*, the need for:

- a) compilation and dissemination of tourism, transport and retail trade statistics at lower geographical level, enhancing policy-making at the level of Region,
- b) compilation of long time series for national accounts, based on a harmonized methodology,
- c) compilation of statistics on abortions performed in public hospitals and private clinics of Greece,
- d) compilation of statistics on suicide and suicide attempts in Greece,
- e) compilation of geospatial data and creation of electronic maps and atlases,
- f) compilation of data on household expenditure on health, social solidarity and education at the level of Region,
- g) compilation of European Community Health Indicators and Monitoring (ECHIM) for monitoring citizens' health and operation of health systems,
- h) compilation of agriculture statistics at a lower geographical level and with more detailed analysis,
- i) compilation of statistics on "tourist consumption expenditure," with a view to identifying the types of expenditures of tourists (Greek and foreign) in Greece and correlating the aforementioned expenditure with consumption expenditure on local products,
- j) development of a navigation mechanism (navigation aid) for the website of ELSTAT.

ELSTAT has studied the comments and suggestions made at the 2nd Users Conference and, within the existing and envisaged constraints of its budget, it is planning to take the following actions in 2012:

- i) Explore the feasibility of increasing the sample size of sample surveys aiming at the production of reliable estimations at levels below Country level.⁽¹⁾

(1) In this framework, after the end of the 2011 Population and Housing Census, ELSTAT conducted a Post-Enumeration Survey—aimed at assessing the completeness and accuracy of the Census results—using a sample of 20,000 households throughout the Country, instead of the 4,500-household sample used for previous Post-Enumerations Surveys. This increase of the sample size will enable ELSTAT to assess the completeness and accuracy of the 2011 Population and Housing Census results at the level of Municipality (as defined by the Kallikratis Plan).

- ii) Consider very carefully the issue of the spatial dimension of statistical data and the corresponding presentation and dissemination of its data (including electronic maps and atlases).
- iii) Explore the possibility of compiling longer time series using a harmonized methodology, taking into consideration the priorities set by the National Accounts Division and the availability of primary data.
- iv) Consider the possibility of developing a website navigation mechanism in the framework of its ongoing efforts to upgrade its website.

C. OTHER CHANGES IN THE COMPILATION AND DISSEMINATION OF STATISTICS

Compliance with EU Regulations and adaptation to user needs, in combination with constraints in terms of available human and financial resources, necessitate changes: improvements, revisions, and discontinuations in the production and dissemination of statistics. The following changes are planned for 2012:

- **LABOUR MARKET**

- *Changes in the data collection and dissemination of the Labour Force Survey results*

The Labour Force Survey (LFS) is conducted through personal interviews on a sample of 32,000 households. For the first interview, the interviewer must visit the residence (to conduct a face-to-face interview). ELSTAT intends to implement a system of follow-up interviews of the same household via telephone—a practice used by the majority of EU Member States. The preparation of the call center will start during the second semester of 2012 and the telephone interview system is expected to start being implemented in 2013.

Changes will also be made in the dissemination of the Labour Force Survey results. Eurostat is already publishing monthly, seasonally adjusted data from the LFS results and ELSTAT is going to use the same data release mode. Furthermore, in the framework of the actions taken by ELSTAT in order to enhance dissemination and presentation of its statistics, and in order to improve the accuracy of the monthly results for unemployment at a level below Country level, ELSTAT is going to release the monthly results of the LFS at the level of the seven (7) Decentralized Administrations (as defined by the Kallikratis Plan).

- **NATIONAL ACCOUNTS**

- *Implementation of the New European System of Accounts, ESA 2010*

For the period 2012-2013 ELSTAT will take all necessary actions for the implementation of the new ESA 2010. The implementation will be completed with the submission of the new results in September 2014. Special surveys and studies are to be conducted so that

the methodology that will be followed in the implementation of the new system fully meets its requirements.

D. RESULTS OF THE AGRICULTURE-LIVESTOCK CENSUS AND OF THE CENSUSES FOR BUILDINGS AND FOR POPULATION-HOUSING

1. 2009 Agriculture-Livestock Census

The processing of the 2009 Agriculture-Livestock Census data is to be completed in the beginning of 2012. The final, tabulated data are expected to be available after the first semester of 2012.

The new updated register of agricultural and livestock holdings, which will be compiled on the basis of the Agriculture-Livestock Census results, will be available in 2012. For the next ten years, this register will be the frame for designing the special Annual Surveys on Agriculture and Livestock and the Survey on the Structure of Agricultural and Livestock Holdings. This Register is a source of information for many users, such as the Ministry of Rural Development and Food (main user), researchers and universities.

2. 2011 General Censuses for Buildings and for Population-Housing

The processing of the data of the 2011 General Censuses for Buildings and for Population-Housing begun in 2011 and will continue in 2012, aiming at having the first results published within 2012.

The compilation of statistics from the 2011 Population-Housing Census must fully meet the requirements of Regulation 763/2008 of the European Parliament and of the Council on population and housing censuses, as well as its implementing Regulations 1201/2009, 519/2010 and 1151/2010. The aforementioned Regulations apply to all Population-Housing Censuses conducted from 2011 onwards and are binding for all EU Member States.

More specifically, Regulation 519/2010 establishes the program of the statistical data and the metadata to be transmitted to Eurostat for the reference year 2011, in compliance with the new transmission system on the basis of ‘hypercubes’ (multidimensional cross tabulation of breakdowns). Regulation 1151/2010 lays down issues regarding the modalities and structure of the quality reports which must be submitted by EU Member States concerning the quality of census results, as well as issues concerning the technical format for data transmission (SDMX), aiming at meeting the requirements of Regulation 763/2008. The analytical tabulated data will mostly refer to the Country’s *resident* and *de jure* population.

The data of the 2011 General Censuses for Buildings and for Population-Housing will be processed using optical character readers (OCR). The relevant software and tools that will be used for data processing are FLEXI CAPTURE 10 (OCR/ICR), ORACLE 10g and DEVELOPER.

In addition, registers are going to be compiled (occupation, branches of economic activity, tertiary education institutions, etc) enriched with synonyms (Thesauruses) aiming at enhancing the electronic codification process. The codification will be based on standard rules, thus eliminating any errors due to human intervention. During the stage of checks, the required corrective actions will be automated, aiming at ensuring the highest quality of final results.

Simultaneously, within 2012 the processing and checking of the questionnaires of the Post Enumeration Survey—which had been conducted in June 2011 on a sample of 20,000 households all over the Country with the aim of assessing the completeness and the quality of collected census data even at the level of Municipality (as defined in the Kallikratis Plan)—will be completed. Subsequently the post enumeration questionnaires are to be matched with the corresponding questionnaires of the Population-Housing Census and then will follow the calculation of raising factors and the tabulation of data.

E. IMPROVING THE QUALITY OF PRODUCED STATISTICS

ELSTAT will continue to put special emphasis on enhancing the reliability, timeliness and, more generally, the quality of produced statistics. In this framework, in 2012, ELSTAT will continue to implement the multidimensional Joint Overall Statistical Greek Action Plan (JOSGAP), which was agreed with Eurostat with the aim of harmonizing the Hellenic Statistical System with the European one.

1. Joint Overall Statistical Greek Action Plan

The Joint Overall Statistical Greek Action Plan (JOSGAP), which was elaborated by the Commission (Eurostat) and the Greek Authorities aiming at the harmonization of the Hellenic Statistical System with the European one, encompasses actions allocated into three pillars—A, B and C—with each action having its own deadline for completion. Since 2010, when the JOSGAP started being implemented, a significant number of these actions have either been completed or are at the stage of finalization.

As regards actions within pillar A, which aim at enhancing the institutional framework of the ELSS, in 2012 emphasis shall be put on the certification of statistics produced by the other ELSS agencies. In 2011, ELSTAT undertook the appropriate preparatory actions and, more specifically, it collected information from the ELSS agencies on the statistics they produce and has elaborated, with the assistance of experts, the general framework for the certification procedure. The certification will be based on the observance of the principles of the European Statistics Code of Practice. The observance of these principles is going to be monitored and assessed by means of relevant tools that have been developed in the European Statistical System (ESS), of which the most recent is the “Quality Assurance Framework” of the ESS, as well as by means of methods used by international organizations (e.g., the International Monetary Fund) and countries which have developed such methods (e.g., the United Kingdom). In the

context of the elaboration of the certification procedure to be implemented for the ELSS, a workshop will be organized in the beginning of 2012 on ELSTAT's premises with the participation of ELSTAT officials and foreign experts. Afterwards, a pilot certification procedure will be implemented for an ELSS agency. ELSTAT is aiming at completing the first certifications of statistics produced by ELSS agencies by the end of 2012. Furthermore, the Regulation on the Operation and Administration of ELSTAT, as well as the new Organization of ELSTAT will be completed within 2012.

In 2012, the works for completing the actions of pillar B will be intensified. These actions aim at improving the processes and capacity for the production of statistics in Greece through a program of short and medium-term technical assistance provided by Eurostat to ELSTAT.

Among the actions of pillar B that are expected to mark significant progress in 2012 are included the development and implementation of projects in the following areas: training of ELSTAT staff; improving and upgrading the existing ICT infrastructure and the corresponding services provided; improving the completeness and updating of the statistical business register; and enhancing the quality of statistics in several areas. These areas include, *inter alia*, Structural Business Statistics, environment statistics, external trade statistics, quarterly national accounts, etc. In 2011, the confirmation of ELSTAT's Managerial Adequacy was issued by the Ministry of Interior, thus making ELSTAT eligible to absorb funds for the implementation of the aforementioned projects.

Finally, within 2012 ELSTAT will continue the implementation of the last remaining actions of pillar C of JOSGAP. These actions focus on improving the quality of government finance statistics. Most of the actions under pillar C have already been completed.

2. Coordinating the actions of ELSS agencies – Council of the Hellenic Statistical System

One of the obligations of ELSTAT, stipulated in the Statistical Law 3832/2010, is the coordination of the activities of the other ELSS agencies pertaining to the development, production and dissemination of the official statistics of Greece. In 2012, the coordinating role of ELSTAT within the ELSS will be more active in light of the initiation of the activities for the certification of the aforementioned statistics.

ELSTAT performs its coordinating role through, *inter alia*, the Council of the Hellenic Statistical System (SYELSS), which is established by Article 3 of the Law 3832/2010. The Council is chaired by the President of ELSTAT and in the Council are represented, *inter alia*, the *National Statistical Authorities*, which are the ELSS agencies responsible for developing, producing and disseminating European statistics.

The first meeting of the SYELSS was convened in June 2011. During this first meeting, the Council approved the Regulation on its Internal Organization and Operation and provided its opinion on the draft Regulation on the Statistical Obligations of the ELSS agencies and on the

Hellenic Statistical Program for 2011-2013. The Council's members were also informed about the draft 2011 Annual Statistical Work Program of ELSTAT. The second meeting of the SYELSS was convened in February 2012. Council members were informed on the following issues: the European Statistics Code of Practice (previous and revised edition); the draft Annual Statistical Program of ELSTAT for 2012; the comments and suggestions made by the participants in the Users Conference held by ELSTAT in 2011; the new publication "*The Greek Economy*"; and the "European Conference on Quality in Official Statistics - Q2012" to be held in Athens in May 2012.

3. Using technology to enhance data collection

In an effort to reduce both the time and the cost of surveys, ELSTAT has as its main aim the use of electronic questionnaires and the conduct of surveys via computer/web applications. In 2011 ELSTAT began, and will continue in 2012, to gradually replace, when deemed necessary, the printed questionnaires—especially those that are used for the collection of data from administrative sources—by electronic ones, to enable data collection through web applications. The register of survey workers has already been compiled on the basis of such a web application, while within 2012 corresponding applications are expected to be finalized for the Labour Force Survey, and to be developed for the Aquaculture and Waste surveys, as well as for the surveys conducted by the Section of Education Statistics and by the Section of Health, Social Solidarity and Protection Statistics of ELSTAT.

F. IMPROVING ACCESSIBILITY OF PRODUCED STATISTICS

1. Upgrading the portal of ELSTAT

In 2012, ELSTAT will continue to improve various aspects of the layout and content of its portal as well as enhance the other dissemination modes for its statistics, with a view to fulfilling users' needs both at national and international level, by following the developing international standards, as well as ensuring the timely update of the ELSTAT website with the most recent statistical data.

The works for redesigning ELSTAT's portal and enriching its content are part of the actions provided for in JOSGAP for 2012 concerning ICT—project for improving and upgrading the existing ICT infrastructure and the corresponding services provided (see paragraph E1). In the framework of this project the following actions are included: upgrading the Integrated Information System of ELSTAT; using up-to-date methods for printing statistical publications (e.g. POD—print on demand); further developing the security policy for computer systems; and enhancing the quality and automation of technical support services.

Some of the works for upgrading ELSTAT's portal have already begun in 2011, namely updating the tables and covering the gaps in the time series data posted on ELSTAT's website, as well as enriching the website with the metadata for all the statistical surveys and works after having ad-

justed them to the European Statistical Data and Metadata Exchange System (ESMS). ELSTAT is planning to have all these works completed by the beginning of 2012.

ELSTAT, responding to users' requests, intends to add on its website hyperlinks which can be followed by researchers in order to find the sources for collecting the data they need. In addition, as already mentioned before, ELSTAT is going to explore the possibility of developing a navigation mechanism for its portal.

Finally, in the framework of upgrading its portal, ELSTAT intends to use XML technology for disseminating its statistics, thus making statistical data both human- and machine- processable.

2. Fostering statistical education

One of the goals that ELSTAT has set for 2012 is the undertaking of actions aiming at promoting statistical education in Greece. To this end, in 2012 the Division of Statistical Information and Publications of ELSTAT intends to undertake certain initiatives that encompass: hosting groups of students in the Library and in other Sections of ELSTAT; making presentations to groups of students and teachers on the work of ELSTAT and delivering relevant information materials. The pupils are going to be informed on the operations of ELSTAT and on all the stages of statistical production, from the designing of statistical surveys/works up to the dissemination of statistics.

In addition, in an effort to get children interested in statistical science, ELSTAT intends to create a specialized webpage which will be addressed to children aged 6-18 years and will offer animations, quizzes and games pertaining to statistics. A special workshop aiming at informing teachers on the aforementioned webpage in going to be organized by the Division of Statistical Information and Publications of ELSTAT.

Finally, in 2012 the Division of Statistical Information and Publications of ELSTAT intends to organize a special "Info-day" aiming at the information of the public on the "treasure" of statistical publications found in the Digital Library of ELSTAT. The digital library counts 3,443 books and magazines and 6 atlases, dating back to 1859. Participants will include representatives of public libraries and publishing companies.

G. CONFERENCES ORGANIZED BY ELSTAT

1. European Conference on Quality in Official Statistics – Q2012

A major statistical event in 2012 will be the organization of the "European Conference on Quality in Official Statistics – Q2012" in Athens, from 29 May to 1 June 2012. ELSTAT is expecting that a significant number of participants are going to attend the conference, including academics and representatives of national and international agencies and organizations concerned with quality in statistics.

Since mid-2012, when ELSTAT was appointed as the Conference organizer by Eurostat, it took up the necessary preparations aiming at organizing a successful event. In November 2011, the Organizing Committee gathered all the abstracts of the scientific papers submitted for the Conference. In December 2011, the Programme Committee had a meeting on ELSTAT premises, chose the abstracts to be presented and dully informed the authors of the papers. At the same time, the Programme Committee elaborated a draft timetable for the conference sessions. In the next stage, the list of the abstracts is to be compiled. The full text of the papers must be submitted by end-April.

2. European Conference on Quality in Official Statistics – Q2012

The Users Conferences that were convened in 2010 and 2011 highlighted their importance and usefulness in enhancing the statistical products and services provided by ELSTAT. The comments and suggestions made by users are thoroughly examined and taken into consideration as much as possible by ELSTAT, while taking into account the constraints regarding available human and financial resources, for the elaboration of its statistical programs. The “Users Conference” has been established as a traditional conference for ELSTAT, and in this context a third Users Conference is slated to be held in 2012 too.

H. BUDGET

ELSTAT’s adopted 2012 budget includes expenditure amounting to fifty-two million eight hundred and tree thousand euros (52,803,000). Out of this total expenditure, the amount of fifty-two million seven hundred and eighty eight thousand euros (52,788,000) is to be funded by the ordinary budget and the rest fifteen thousand euros (15,000) are going to be covered by proceeds coming from the sale of ELSTAT’s publications.

ELSTAT’s expenses are classified in 9 categories:

- a) Wages and salaries of ELSTAT’s permanent staff, including basic salary, allowances, social security contributions, etc.
- b) Remuneration of personnel on limited-term contracts under private law.
- c) Additional and incidental benefits for the permanent staff.
- d) Expenses related to staff traveling within Greece and abroad: travel and subsistence expenses for the permanent staff of ELSTAT moving out of the Office, for conducting statistical surveys in the field or for participating in meetings, seminars, etc. abroad, as well as expenses related to the transfer or detachment of ELSTAT employees to other Services, in Greece or abroad.
- e) Other operating expenses, including expenses related to ELSTAT’s property—buildings (Central and Regional Offices) such as rents, heating, communication, water supply, secu-

rity, cleaning and maintenance costs, advertisement and public relations expenses, temporary staff remuneration costs, etc.

- f) Expenses for the provision of goods and capital stock, including expenses for the provision of consumables (paper, stationery, medical and pharmaceutical supplies, materials for the maintenance and repair of premises and equipment), fuel, furniture, PCs, printers, photocopiers and other office equipment.
- g) Expenses for the recruitment of personnel.
- h) Expenses for the conduct of censuses for buildings, population-housing and for the agricultural census.
- i) Projects financed by Eurostat, including expenses in the context of the conduct of statistical works financed by Eurostat.

After the enactment of the unified wage law for the public sector, expenditure of type a) above has considerably increased while expenditure of type c) has significantly decreased in comparison with the corresponding expenditure items in the 2011 budget of ELSTAT.

The allocation of expenses of the adopted 2012 ELSTAT budget, by type of expenditure, is presented in the following table:

ANNEX
