

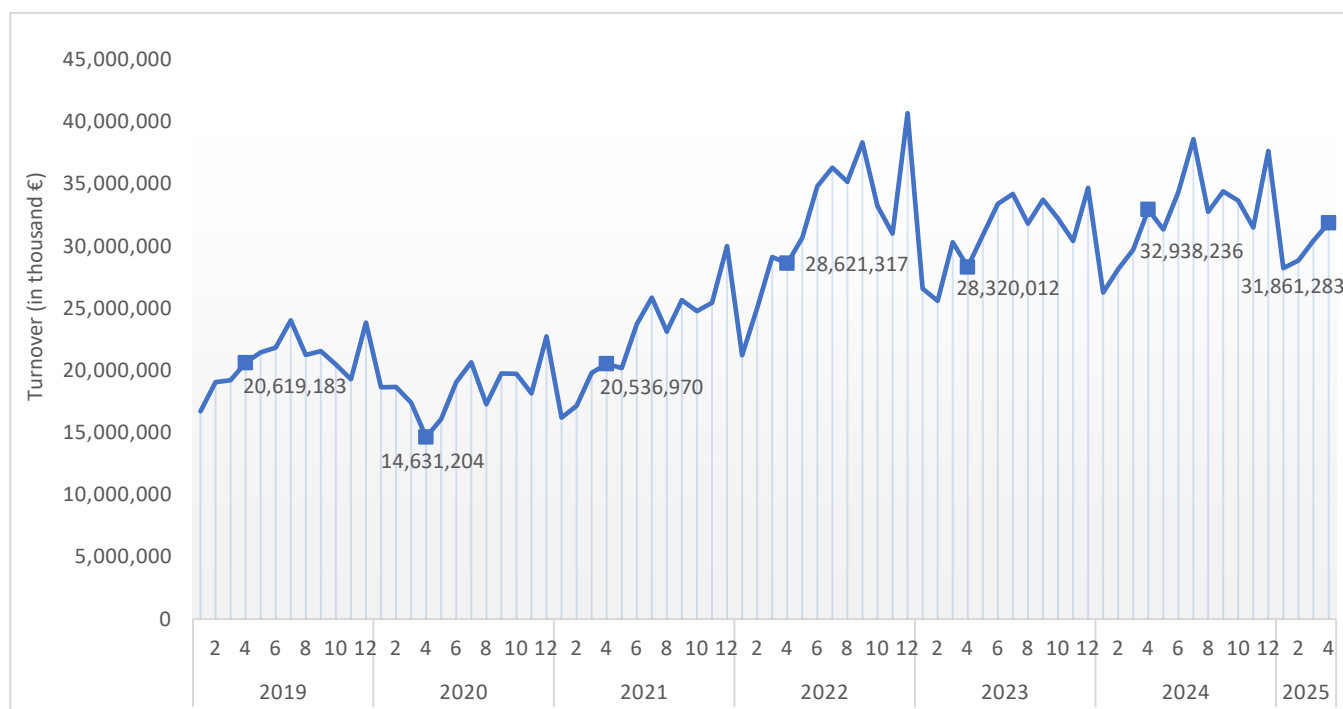


## EVOLUTION OF TURNOVER OF ENTERPRISES APRIL 2025

The Hellenic Statistical Authority (ELSTAT) announces data on the evolution of turnover of enterprises in all sectors of the economy, incorporating the most recent data on turnover from Administrative Sources for **April 2025**.

**For the enterprises of the economy as a whole, obliged to double-entry accounting bookkeeping**, for which data are available on a monthly basis, the turnover in April 2025 amounted to 31,861,283 thousand euro, recording a decrease of 3.3% in comparison with April 2024, when the respective turnover was 32,938,236 thousand euro (Graph 1, Table 1).

The biggest decrease in turnover in April 2025 compared with April 2024 was recorded from the enterprises of the section Manufacturing, per 8.6%, while the biggest increase was recorded from the enterprises of the section Electricity, Gas, Steam and Air Conditioning Supply, per 20.5% (Table 1).

**Generally** The current announcement provides statistical data on turnover for all enterprises and sections of the economy.

These statistical data have been compiled on the basis of the linking and processing of primary data from the following sources:

- The final Statistical Business Register of ELSTAT, of the reference year 2022.
- Administrative transactions files (tax, etc) of the reference years 2019 to 2025.

In particular, the following primary data have been used per source:

- Active enterprises and the economic activity class from the final Statistical Business Register of the reference year 2022.
- Income data from administrative transactions files of the reference years 2019 to 2025.

**Statistical classifications** For the economic activities, the European statistical classification of economic activities [NACE Rev. 2](#) is used.

**Reference Period** April 2025.

**Statistical unit** The statistical unit is the legal unit (distinct TIN).

**Comparability** The announced statistical data are comparable with the data of the final Statistical Business Register of ELSTAT, of the reference year 2022 (relevant link from the webpage of ELSTAT, where tables and information on the methodology applied are provided [Statistical Business Register](#)).
