
BUSINESS DEMOGRAPHY, 2023

The Hellenic Statistical Authority (ELSTAT) announces data on business demography in Greece and specifically, on <u>active</u> enterprises, <u>births of enterprises</u>, <u>deaths of enterprises</u>, <u>high growth enterprises</u>, and for <u>the young high growth enterprises</u> (gazelles)¹, for the year 2023.

The number of active enterprises operating in Greece in the sectors of manufacturing, construction, trade, and services² amounted to 932,549 in the year 2023, while the number of enterprise births and enterprise deaths amounted to 78,754 and 31,628 respectively (Graph 1, Table 1).

The total employment of the active enterprises amounted to 3,488,231 persons, while the total employment of the enterprise births and deaths amounted to 158,849 and 46,050 respectively (Table 2).

This is because the population of active enterprises also includes cases of reactivations, as well as enterprises resulting from restructuring processes of enterprises (such as break-up or split-off), which are not classified as enterprise births, according to the statistical definitions of business demography, provided in the section "Methodological Notes", on page 14.

Data for Active enterprises, Births of enterprises and Deaths of enterprises, for the year 2023 (Tables 1, 3)

Out of the 932,549 active enterprises 697,484 were sole proprietorships, while 574,264 had no employees.

The sections with the biggest number of active enterprises were wholesale and retail trade with 222,793 enterprises, accounting for 23.9% of the total number of the above enterprises, professional, scientific and technical activities with 161,222 enterprises, accounting for 17.3%, followed by accommodation and food service activities with 108,413 enterprises corresponding to 11.6%.

Out of the 78,754 births of enterprises, 54,193 were sole proprietorships, while 61,169 had no employees.

The sections with the biggest number of enterprise births were professional, scientific and technical activities with 14,693 enterprises (18.7%), wholesale and retail trade with 13,001 enterprises (16.5%), followed by accommodation and food service activities with 9,616 enterprises (12.2%).

Out of the 31,628 deaths of enterprises, 28,998 were sole proprietorships, while 25,047 had no employees.

The sections with the biggest number of enterprise deaths were wholesale and retail trade with 8,492 enterprises (26.8%), accommodation and food service activities with 5,371 enterprises (17.0%) and professional, scientific and technical activities with 5,240 enterprises (16.6%).

1. ACTIVE ENTERPRISES

1.1. Sections of Economic Activity by Employees' Size Class of the enterprise (Table 1)

The sections of economic activity with the biggest number of active enterprises by Employees' Size Class are:

- No Employee: Professional, Scientific and Technical Activities, with 129,440 active enterprises.
- 1-4 Employees: Wholesale and Retail Trade; Repair of Motor Vehicles and Motorcycles, with 83,439 active enterprises.
- 5-9 Employees: Accommodation and Food Service Activities, with 13,821 active enterprises.
- 10 Employees or more: Accommodation and Food Service Activities, with 16,246 active enterprises.

1.2. Sections of Economic Activity by category of Legal Form of the enterprise (Tables 3, 4)

The sections of economic activity with the biggest number of active enterprises by category of Legal Form are:

- Sole Proprietorships: Wholesale and Retail Trade; Repair of Motor Vehicles and Motorcycles, with 160,298 active enterprises and 285,744 persons employed.
- Limited Liability Enterprises: Wholesale and Retail Trade; Repair of Motor Vehicles and Motorcycles, with 22,071 active enterprises and 344,753 persons employed.
- Partnership Enterprises: Wholesale and Retail Trade; Repair of Motor Vehicles and Motorcycles, with 40,424 active enterprises and 208,385 persons employed.

2. BIRTHS OF ENTERPRISES

2.1. Sections of Economic Activity by Employees' Size Class of the enterprise (Table 1)

The sections of economic activity with the biggest number of enterprise births by Employees' Size Class are:

- No Employees: Professional, Scientific and Technical Activities, with 13,767 enterprise births.
- 1-4 Employees: Accommodation and Food Service Activities, with 3,591 enterprise births.
- 5-9 Employees: Accommodation and Food Service Activities, with 1,130 enterprise births.
- 10 Employees or more: Accommodation and Food Service Activities, with 1,002 enterprise births.

2.2. Sections of Economic Activity by category of Legal Form of the enterprise (Tables 3, 4)

The sections of economic activity with the biggest number of enterprise births by category of Legal Form are:

- **Sole Proprietorships**: Professional, Scientific and Technical Activities, with 11,849 enterprise births and 11,023 persons employed.
- Limited Liability Enterprises: Wholesale and Retail Trade; Repair of Motor Vehicles and Motorcycles, with 1,856 enterprise births and 7,328 persons employed.
- Partnership Enterprises: Accommodation and Food Service Activities, with 2,787 enterprise births and 21,845 persons employed.

3. <u>DEATHS OF ENTERPRISES</u>

3.1. Sections of Economic Activity by Employees' Size Class of the enterprise (Table 1)

The sections of economic activity with the biggest number of enterprise deaths by Employees' Size Class are:

- No Employees: Wholesale and Retail Trade; Repair of Motor Vehicles and Motorcycles, with 6,599 enterprise
 deaths.
- 1-4 Employees: Wholesale and Retail Trade; Repair of Motor Vehicles and Motorcycles, with 1,792 enterprise deaths.
- 5-9 Employees: Accommodation and Food Service Activities, with 319 enterprise deaths.
- 10 Employees or more: Accommodation and Food Service Activities, with 179 enterprise deaths.

3.2. Sections of Economic Activity by category of Legal Form of the enterprise (Tables 3, 4)

The sections of economic activity with the biggest number of enterprise deaths by category of Legal Form are:

- Sole Proprietorships: Wholesale and Retail Trade; Repair of Motor Vehicles and Motorcycles, with 7,606 enterprise deaths and 8,775 persons employed.
- Limited Liability Enterprises: Wholesale and Retail Trade; Repair of Motor Vehicles and Motorcycles, with 119 enterprise deaths and 413 persons employed.
- Partnership Enterprises: Wholesale and Retail Trade; Repair of Motor Vehicles and Motorcycles, with 767 enterprise deaths and 1,871 persons employed.

4. NUMBER OF HIGH GROWTH ENTERPRISES AND YOUNG HIGH GROWTH ENTERPRISES (GAZELLES) (Table 5)

High growth enterprises for 2023 are those that had at least 10 employees in 2020, and an average annualised growth in the number of employees bigger than 10 % per annum, during the period 2020 - 2023.

The number of high growth enterprises in 2023 amounted to 7,995 enterprises, with 520,334 employees.

The biggest number of high growth enterprises was recorded in the economic activity section Accommodation and Food Service Activities, with 3,009 enterprises, accounting for 37.6% of the total number of the above enterprises and 162,322 employees, followed by the sections of Wholesale and Retail Trade, Repair of Motor Vehicles and Motorcycles, with 1,516 enterprises (19.0%) and 83,012 employees and Manufacturing with 984 enterprises (12.3%) and 64,132 employees.

Young high growth enterprises (gazelles) for 2023 are those that were established in the year 2018 or 2019, had at least 10 employees in 2020 and an average annualised growth in the number of employees bigger than 10% per annum, during the period 2020 - 2023.

The number of young high growth enterprises in 2023 amounted to 875 enterprises, with 40,226 employees.

The biggest number of young high growth enterprises (gazelles) was recorded in the economic activity section Accommodation and Food Service Activities, with 428 enterprises, accounting for 48.9% of the total number of the above enterprises and 15,337 employees, followed by the sections of Wholesale and Retail Trade, Repair of Motor Vehicles and Motorcycles, with 100 enterprises (11.4%) and 4,309 employees and Administrative and Support Service Activities with 50 enterprises (5.7%) and 5,467 employees.

5. <u>ACTIVE ENTERPRISES, BIRTHS AND DEATHS OF ENTERPRISES AND HIGH GROWTH ENTERPRISES, PER REGION OF GREECE (Table 6)</u>

The biggest percentage of active enterprises was recorded in the following Regions:

- Region of Attiki, 39.02%.
- Region of Kentriki Makedonia, 16.01%.

The biggest percentage of enterprise births to active enterprises was recorded in the following Regions:

- Region of Attiki, 9.44%.
- Region of Notio Aigaio, 8.60%.

The biggest percentage of enterprise deaths to active enterprises was recorded in the following Regions:

- Region of Dytiki Makedonia, 4.70%.
- Region of Anatoliki Makedonia, Thraki, 4.42%.

The biggest percentage of high growth enterprises to active enterprises was recorded in the following Regions:

- Region of Notio Aigaio, 1.42%.
- Region of Kriti, 1.27%.





Graph 2: Percentage distribution (%) of the number of active enterprises, births of enterprises and deaths of enterprises, by employees' size class, 2023










METHODOLOGICAL NOTES

General Information

Business demography statistics refer to active enterprises, births of enterprises and deaths of enterprises, which are defined as follows:

<u>Active enterprises</u>: The number of all statistical units which at any time during the reference period were "enterprises", as defined in <u>Council Regulation (EEC) No 696/93</u>, and also active (have turnover or employment) during the same reference period.

<u>Births of enterprises</u>: An enterprise birth occurs when an enterprise starts from scratch and begins operations, amounting to the creation of a combination of production factors with the restriction that no other enterprises are involved in the event. Enterprises created solely as a result of e.g. restructuring, merger or break-up are not considered as enterprise births. Entries into a sub-population resulting only from a change of activity are also excluded.

<u>Deaths of enterprises</u>: An enterprise death is the termination of an enterprise, amounting to the dissolution of a combination of production factors with the restriction that no other enterprises are involved in the event. Enterprises closed solely as a result of e.g. restructuring, merger, take over or break-up are not considered as enterprise death. Exits from a sub-population resulting only from a change of activity are also excluded.

Moreover, business demography statistics include data for:

- a) <u>high growth enterprises, measured in employment</u>. The enterprises having at least 10 employees in year t-3, with average annualised growth in number of employees greater than 10 % per annum, over a three-year period (t-3 to t) are characterised as high growth enterprises. Births of enterprises during "t-3" period are not included.
- b) **young high growth enterprises, measured in employment**. Gazelles, as a subset of high growth enterprises, must fulfil the additional condition that they belong to the population of enterprise births of period "t-3".

The data are compiled by **economic activity of the enterprise** (<u>NACE Rev.2</u>), **legal form** and **employees' size class** in order to highlight specific demographic patterns.

The economic activities covered by business demography are NACE Rev.2 sections B to N, and P to R and divisions S95 and S96.

The categories of legal form or enterprises are the following:

- Sole Proprietorships: Personally owned enterprises with no limit to personal liability.
- **Limited Liability Enterprises**: Private or publicly quoted joint stock companies with limited liability for those owning shares.
- Partnership Enterprises: Personally owned limited and unlimited liability partnerships. Included are also other forms such as co-operatives, associations etc.

The number of persons employed and the number of employees are defined as follows:

<u>Number of persons employed</u>: The total number of persons who work in the enterprise, including the working proprietors, partners and unpaid family members, as well as persons who work outside the enterprise, belong to it and are paid by it.

<u>Number of employees</u>: The number of persons who work for an employer, have a contract of employment and receive compensation in the form of wages, salaries, fees, gratuities, piecework pay or remuneration in kind.

Legal framework

The statistical data on business demography are compiled pursuant to Regulation (EU) 2019/2152 of the European Parliament and of the Council, of 27 November 2019 and Commission Implementing Regulation (EU) 2020/1197, of 30 July 2020.

Compilation methodology


The compilation of statistical data for business demography is based on the analysis and processing of data obtained from the Statistical Business Register of ELSTAT, in combination with Structural Business Statistics.

Differences observed in tables 1 to 4 of this Publication, between the number of enterprises and the respective number of persons employed, where the number of enterprises is bigger than the number of persons employed, are created by enterprises born within the reference year (2023) that, didn't have, yet, during this year, started their full operation (they didn't yet have created turnover and hired employees) and by enterprises that died within the reference year (2023) and they didn't have, during this year, turnover and employees.

Statistical classifications

As regards the economic activities, the European statistical classification of economic activities <u>NACE Rev.2</u> is used.

Statistical unit

The statistical unit "enterprise" is used. According to <u>Council Regulation (EEC) No 696/93</u>, the enterprise is the smallest combination of legal units that is an organisational unit producing goods or services, which benefits from a certain degree of autonomy in decision-making, especially for the allocation of its current resources. An enterprise can carry out one or more activities at one or more locations. An enterprise may be a sole legal unit.

Comparability

Business demography statistics since reference year 2021 are compiled with an updated methodology in the framework of the implementation of Regulation (EU) No 2019/2152 of the European Parliament and of the Council, which provides for maximum consistency between Business Demography, Structural Business Statistics and Statistical Business Register and therefore are not directly comparable with the corresponding business demography results for the years 2019-2020.

Annual Business Demography statistics are not directly comparable with quarterly business demography statistics (Registrations and Bankruptcies), as the annual Business Demography is compiled mainly based on the Statistical Business Register, while quarterly demography draws data from the Administrative Business Register and the Electronic Solvency Register.
